MINUTES WEAVERVILLE FIRE PROTECTION DISTRICT

Regular Meeting - April 5, 2022

- I. CALL TO ORDER: The Regular Meeting of the Weaverville Fire Protection District was called to order by Chairman Larry Helsley at 1000 hours. Commissioners present: George Owen, Rick Wetzel, and Todd Watkins. Commissioners absent: Bill Fischer. Others present: Fire Chief Todd Corbett, and Admin Officer Serena Brown.

Report: The Board approved Chief Corbett's review of the Admin Officer's yearly performance evaluation. A 5% increase in pay, retroactive to the beginning of the year, was approved. The Budget Committee is going to research a salary adjustment.

- V. DEPARTMENT AND BUSINESS REPORTS
 - a. Hazardous Reduction Progress Report: Chief Corbett reported that:
 - i. We have, officially, been awarded Title III funding in the amount of 35,000.

- ii. The winter crew is done needed burning and the summer crew will start working soon.
- b. Fire Chief's Report: Chief Corbett reported that
 - i. He did the final Life Safety Inspection on the Redding Rancheria Clinic. It will be opening to the public soon.
 - ii. He completed the final Sprinkler Inspection on Holiday Market
 - iii. There was a workday at the training grounds including teardown of some of the old fire props. We should be able to move forward with training soon.
 - iv. We fought our first vegetation fire of the season off Ransom Rd
 - v. The insurance policy for historic fire hall is still being worked on
 - vi. Our ISO 5-year survey has been completed and submitted. The Water District is responsible for 45% of the rating and they didn't complete their portion of the survey. A waiver has been submitted. Commissioners expressed concerns regarding the maintenance of the fire hydrants and wondering if a more formal complaint should be initiated.
- c. Fire Department Report: Chief Corbett reported that
 - i. We have run to-date 166 calls for service. March was a busy month with 55 calls being ran.
 - ii. We have 30 members.
 - iii. Last month we completed 120 man-hours of training including a tour and preplan of the new Jail
 - iv. The weekend of April 30th is our County-wide Wildland preparedness drill,
 - v. Our annual appreciation dinner is turning into a Bar-B-Q at Alvord's house on May 14th.
 - vi. Helsley asked about Chiefs' meeting... USFS Local agreements was the main topic of conversation at the meeting. SPI Lawyers, County, State, and Federal officials are all getting involved.
 - vii. Wetzel asked if there was any word on when burning restrictions were going into place. There is not any information, but CalFire will soon be staffing engines... which is about a month earlier than normal.
- d. Sleeper Program: Chief Corbett reported we no longer have any sleepers. He is researching perspective sleepers.
- e. Committee Reports
 - i. Collections Committee: We billed a recent call but have not received any response.
 - ii. Contract Committee: No report
 - iii. Budget Committee: Will meet soon regarding topics discussed in today's Closed Session
 - iv. Policy committee: Nothing additional
- f. Director Reports: Owen asked about the new ice machine. Which will be installed and ready for use prior to Fire Season. Helsley asked about the warning beacon and Corbett reported that Supervisor Jill Cox is still checking on it. The County is busy trying to fill the CEO position.
