

MINUTES WEAVERVILLE FIRE PROTECTION DISTRICT

Regular Meeting - December 3, 2019

- I. CALL TO ORDER: The Regular Meeting of the Weaverville Fire Protection District was called to order by Commissioner Rick Wetzel at 1001 hours. Commissioners present: Larry Helsley, Bill Britton, Bill Fischer and George Owen. Others present: Fire Chief Todd Corbett, Assistant Chief Henry Boorman, and Administrative Officer Serena Brown.

 - a. Approve Regular Meeting Minutes November

a. Discuss/Approve – Fred Maddox Proposal. Chief Corbett reported that he spoke with Jennifer Aho, our insurance agent. She strongly recommends against the arrangement due to increase in liability. Commissioner George Owen doesn't agree with Jennifer's assessment. The Board directed Chief Corbett to speak with Jim Underwood for his opinion.

b. Discuss/Approve - Asbestos Reports for the Swiss Village Live Fire Training, Budget impact \$5,300.00. Chief Corbett explained that to get the opportunity to burn these buildings this is our portion of the asbestos testing.
