

MINUTES WEAVERVILLE FIRE PROTECTION DISTRICT

Regular Meeting - March 7, 2023

- I. CALL TO ORDER: The Regular Meeting of the Weaverville Fire Protection District was called to order by Chairman Rick Wetzel at 1001 hours.
