

## MINUTES WEAVERVILLE FIRE PROTECTION DISTRICT

Regular Meeting - December 6, 2018

- CALL TO ORDER: The Regular Meeting of the Weaverville Fire Protection District was called to order by Chairman, larry Helsley at 0958 hours. Commissioners present: Bill Britton and Rick Wetzel. Commissioners Absent: George Owen and Bill Fischer. Others present: Fire Chief Todd Corbett and Administrative Officer Serena Brown.

- a. Discuss/Approve Policy 3.18 Investments There was a short discussion on the new policy. There was one change noted in the Section Code number.

- b. Discuss/Approve banking and investment alternatives Since the last meeting we have learned that Edward Jones can't manage our accounts. Commissioner Helsley pursued another avenue with a gentleman whose name is John Winn. He is not able to take over our accounts either. More research is going to be needed and an Ad Hoc committee is needed.

## IV. DEPARTMENT AND BUSINESS REPORTS

- a. Hazardous Reduction Progress Report Chief Corbett reported that crews are currently working one day a week. They have started burning the piles that were built during the summer. There is still no info on Title III funding.
- b. Fire Chief's Report: Chief Corbett reported that he was gone half the month on the Camp Fire. He has completed preliminary inspections on the new Trinity Hospital clinic sprinkler system. The areal ladder testing has been completed and passed. SCBA annual testing is done. At the Chief's Meeting it was

- reported that the Planning Department is looking into Class K housing which makes homeowner-built structures exempt form sprinklers, no fire department hook up for tanks, no road requirements, and other items. The Fire Chiefs are opposing the idea.
- c. Fire Department Report: Chief Corbett reported that we currently have 27 members and have ran on 479 calls. We attended a career day at Trinity High School during their lunch hour. There is a Holiday Dinner meeting tomorrow and all the commissioners are invited. We had 6 members out of the area for Camp Fire and were still able to cover our District. There was a vegetation fire and apartment fire in the same day.
- d. Sleeper Program Report: Chief Corbett reported that the floors need to be strip and waxed in the meeting hall.
