MINUTES WEAVERVILLE FIRE PROTECTION DISTRICT

Regular Meeting - February 5, 2019

- CALL TO ORDER: The Regular Meeting of the Weaverville Fire Protection District was called to order by Chairman, Rick Wetzel at 1000 hours. Commissioners present: Bill Britton, Larry Helsley, George Owen, and Bill Fischer. Others present: Captain Ted Pierce, Firefighter Jordan Hamilton, Assistant Chief Boorman, and Administrative Officer Serena Brown.

- a. Discuss/Approve Banking and Investment Alternatives After much research the Investment
 Committee believes that the best course of action, for dealing with Morgan Stanly exiting the public funds
 business, is to move with Chris Beeman to Wells Fargo Advisors. There was discussion on other avenues.
 MSC Fischer/ Helsley to move both the investment and operations accounts to Wells Fargo Advisors
- b. Discuss/Approve District vs. Department Recruitment Committee It was reported, to the Association, that the District's Recruitment Committee was specificly for recruiting a Fire Chief. The Association created its own Requirement/Retention committee for Firefighters. Britton's impression was that the Recruitment/Retention committee was a standing committee because the District is nothing without Volunteers. Because membership has been so high there was no reason for the District's Committee to meet. Pierce gave a lengthy report on the Association's current plans including the appointment of himself, Justin Henderson, and Richard Miller to the committee. Pierce thinks one committee is enough and the Association should report to District. Britton also added that a good retention tool is the CSFA Length of Service Award.

Bill suggested saving money until Spring. Chief Corbett is at the Trinity County Board of Supervisors Meeting trying to secure Tittle III moneys. Commissioner Wetzel is wondering why the District doesn't invest money into these projects. It was suggested that the District match Title III funds. The Board asked Captain Pierce to bring a proposal to the next meeting on spending District funds for Hazard Reduction. It is to be on the agenda next month as an action item.
